I hereby declare that the Racing Income shall be included in my Income Tax Return and the taxes due on such income shall be paid by me.

I hereby agree not to hold the Club responsible in the event of any accident or mishap or damage to my horse (s) happening either on the track or in the stable or elsewhere in the Club.

I hereby declare that in case of any demand raised on the Club for my non compliance of any Rules / Statute, as applicable from time to time, I will keep the Club, the Stewards and the Officials of the Club absolved from any such financial liabilities or whatsoever.

My husband/wife (as the case may be) is approved as Owner. I agree that in the event of the Stewards taking action against him / her, it would be open for the Stewards to inquire into my Ownership and, at their discretion, to either revoke my approval or prohibit the transfer of horses from such person to me.

I will personally be responsible for all liabilities arising out of the upkeep and maintenance of the Horse including payment of Basic Training Fees, all other expenses incurred in the running and upkeep of horses owned or part-owned by my wife / husband or in the name of my Company / Firm etc..
