## **THE GENERAL MANAGER RACING ROYAL CALCUTTA TURF CLUB**

*Dear Sir,*

*I hereby appoint Mr. \_\_\_\_\_ to enter, scratch and declare horses, and to act for me generally as my Authorised Agent with authority to appoint a Sub-Agent or Sub-Agents under Rule 1 of the R.C.T.C. Rules of Racing for Season 20\_\_\_\_ 20\_\_\_\_ or for the \_\_\_\_\_ Race Meeting 20\_\_\_\_\_ .*

*I also empower my Authorised Agent or Sub-Agents to pay and receive monies on my behalf.*

*I also empower my Trainer (who holds a licence under the R.C.T.C. Rules of Racing), to enter, scratch and declare horses, and to act for me generally as my Authorised Agent under the Rules of any of the Turf Authorities of India.*

*I also empower the General Manager Racing, R.C.T.C. to pay Basic Training Fees and Livery Charges from my account with R.C.T.C. as and when due.*

*I also expressly authorize and empower the General Manager Racing, R.C.T.C., after obtaining the consent of the Stewards of the R.C.T.C. and subject to the conditions stated over leaf to sell any of the horses or my share in any of the horses registered in my name by public auction :-*

***If there be a debit balance in my accounts for two consecutive months.***

*and to apply the same proceeds in payment of my dues to the R.C.T.C. and to credit to my account any excess that may be realized. In case if there still remains a deficit then I undertake to clear the balance due within fourteen days of the auction of my share in the horse.*

*I agree to abide by the conditions overleaf.*

**CONDITIONS**

1. *In the event of an owner's account being in debit for a period of two consecutive months owing to inadequacy of funds in the owner's accounts or any other reason whatsoever, the General Manager Racing, R.C.T.C., will communicate to the owner forthwith to place his account in credit.*
2. *If the owner fails to comply with such requirement within two weeks of such communication, the General Manager Racing, R.C.T.C., after obtaining the consent of the Stewards may sell by public auction any horses or any share of any horses registered in the owner's name.*
3. *Such public auction shall ordinarily be held at the Calcutta Race Course after the last race on any race day but may be held at any other time or place as the Stewards of the R.C.T.C. may determine.*
4. *If any horse to be auctioned does not invite a single bid, such horse will be re-auctioned after expiry of fortnight.*
5. *If at such second auction also, the horse does not invite a single bid, the R.C.T.C. and/or Trainer would be entitled to give away such horse to a riding school or to any institution or to any person desiring to use the horse as a Hack. If, however, in spite of efforts to find a home for the horse concerned, if it does not become possible to do so, the R.C.T.C. will again inform the owner concerned in writing that such owner should remove the said horse from the premises of the Club within a fortnight of the date of such letter and also intimate that in the alternative the R.C.T.C. will be reluctantly compelled to put down the said horse on humanitarian grounds and in any of the aforesaid events the R.C.T.C. will not be liable or responsible to the owner concerned in any way or manner whatsoever.*
6. *I expressly authorize and empower the G M Racing, R.C.T.C., to have any horse of mine destroyed if the Senior Veterinary Surgeon certifies that it is suffering from any disease specified in **Appendix 'G'** of the R.C.T.C. Rules of Racing or any other notifiable disease or from any disease that may infect or endanger other horses and if the Stewards of the Turf Club order such destruction, and I further agree that in the event of such destruction I shall not be entitled to any compensation from the R.C.T.C. or any of its Officials.*
