

**STIPENDIARY STEWARDS REPORT**  
**CALCUTTA RACES**  
**MONSOON MEETING, SECOND DAY, TUESDAY, 10<sup>th</sup> JULY 2018**

**1<sup>st</sup> RACE (8) THE RELIABLE HANDICAP – For Horses Rated 1-26 – To be ridden by Jockeys of Indian Nationality (About) 1200 Metres (2.00/2.02) : 12 runners**

GLAMOUROUS GLORY (Shezad Khan) was fractious while being stalled.

I ME N MYSELF (Md Imran) and DEAN'S DAYLE (App P Tejeshwar) were slow to begin.

Jockey Shezad Khan, the rider of GLAMOUROUS GLORY (drawn 11), was fined Rs. 1,500/- for coming 'in' sharply soon after the start and causing interference to DARK ANGEL (Hindu Singh, drawn 9) and BLAZE TO GLORY (Rajinder Singh, drawn 10) and a further sum of Rs. 3,000/- for the excessive use of the whip (1<sup>st</sup> offence).

**2<sup>nd</sup> RACE (9) THE HOKAIDO PLATE – A Handicap for Maiden Horses 3 years old only – Rated 21-46 (About) 1200 Metres (2.30/2.34) : 8 runners**

STELVIO PASS (C S Jodha), GRINGO (Arshad Alam) and EKAKIN (Hindu Singh) were fractious while being stalled.

AIYANA (App P Tejeshwar) which was fractious in its stall jumped awkwardly 'inwards' from its stall.

SEVENTH STEP (R Shelar) was slow to begin.

ROMANTIC ZEAL (C Alford, drawn 4) and EKAKIN (Hindu Singh, drawn 5) made contact with each other soon after the start.

GRINGO (Arshad Alam) travelling along the rail and racing fiercely during the early stages of the race had to be repeatedly checked by its rider to avoid running into the heels of the front runners.

**3<sup>rd</sup> RACE (10) THE APPOLOTINA HANDICAP – For Horses Rated 21-46, Rated 1-26 eligible – To be ridden by Jockeys of Indian Nationality (About) 1200 Metres (3.00/3.02) : 11 runners**

SHANAYAA'S PET (App Aditya Kr. Jaiswal) stumbled soon after the start.

At the conclusion of an enquiry into the running and riding of b g PRINCE OF HEART, Trainer Mr. Manvendra Singh was fined a sum of Rs. 5,000/- for the indifferent running of his charge and Jockey Afzal Khan was fined a sum of Rs. 2,500/- for the tender handling of his mount throughout the race. Further Tr. Manvendra Singh was informed that his charges should run in such manner that leaves no room for query.

**4<sup>th</sup> RACE (11) THE TRUE COLOURS HANDICAP – For Horses Rated 21-46, Rated 1-26 eligible – To be ridden by Jockeys of Indian Nationality (About) 1100 Metres (3.30/3.32) : 12 runners**

ALIEN (Md Shabbani) and GLORIOUS RUN (App Aditya Kr. Jaiswal) were slow to begin.

Jockey Afzal Khan, the rider of PERFECT BALANCE, was severely reprimanded in the presence of Tr. Patrick Quinn for failing to ride out his mount to complete advantage during the final stages of the race.

CRYSTAL BALL (App Muzammil Hashmi) finished the race detached from the field. Tr. Shafiq Khan was advised not to accept with his charge until it was capable of a better performance.

**5<sup>th</sup> RACE (12) THE ARTESIA CUP – A Handicap for Horses Rated 81 & above, Rated 61-86 eligible (About) 1100 Metres (4.00/4.04) : 10 runners**

THE TALISMAN (App Nikhil Naidu) which arrived late to the start thereby delaying the proceedings was slow to begin when the start was given. Tr. Vijay Singh was advised to ensure that his charge arrives on time in future.

RULE DOWNUNDER (Sarvan Kumar) was slow to begin.

AMOROUS WHITE (App R S Bhati) and SHIVALIK STORY (S John) made contact with each other approaching the 800 metres.

**6<sup>th</sup> RACE (13) THE SREEPRIYA HANDICAP – For Horses Rated 41-66, Rated 21-46 eligible (About) 1400 Metres (4.30/4.33) : 12 runners**

MICHAELA (B Mahesh) which was fractious while being stalled was slow to begin and finished the race detached from the field. Tr. J E Mckeown was advised not to accept with his charge until it was capable of a better performance.

DIXIE DIAMOND (Shezad Khan) and BANG BANG (App R S Bhati) were slow to begin.

LOCHINVAR (B L Paswan) was squeezed for room immediately after the start due to the crowding of the field.

Jockey Arshad Alam, the rider of EL CID, was fined a sum of Rs. 3,000/- for the excessive use of the whip (1<sup>st</sup> offence) and a further sum of Rs. 2,000/- for the excessive force used with the whip.

**7<sup>th</sup> RACE (14) THE SOPHISTICATED LADY HANDICAP – For Horses Rated 1-26 – To be ridden by Jockeys of Indian Nationality (About) 1400 Metres (5.00/5.06) : 12 runners**

GOD SAVE THE REST (A Imran Khan) and AFRIQUE (Vinay Jaiswal) were fractious while being stalled.

App Nikhil Naidu, the rider of COOL CONQUEROR, was fined a sum of Rs. 1,500/- for failing to ride to his declared weight.

GRAND FOREST (Arshad Alam) trailed the field throughout the race. Tr. Vikash Jaiswal was advised not to accept with his charge until it was capable of a better performance.

Jockeys S John, the rider of SMITH AND WESSON and Jockey Ranidan Singh, the rider of CONSTANCE were fined a sum of Rs. 3,000/- each for excessive use of the whip (1<sup>st</sup> offence).
