Dear Member

On behalf of the Stewards, Royal Calcutta Turf Club, I take this opportunity of extending a warm welcome to you and write to inform you that the lounge, bar, billiard / snooker, gymnasium, steam and sauna facilities are available at the **RESERVE STAND**, Royal Calcutta Turf Club (Calcutta Race Course) on all days except Monday.

**Reserve Stand Timings**: Tuesday to Sunday – 11am to 11pm.

The Restaurant and Bar facilities are operational during these hours.

Entry and Exit from the Kidderpore gate.

A 'Menu Card' comprising of Continental, Chinese & Indian options for Snacks, Dinner and Lunch would be available during operational hours at the Reserve Stand.

The **BILLIARD** / **SNOOKER ROOM** timings are from **1:00** noon to **9.30** pm. Entry for children below the age of 16 years is restricted during racing hours (Interstate Betting Operation & Live Racing hours) in the Club.

The CLUB BAR shall be operational from 11:00 am to 11:00 p.m. on Tuesday to Sunday. Liquor supplied from the Bar would have to be consumed by the time fixed for closing under the Excise Rules. The Excise Rules applicable from time to time shall be strictly followed. Children below the age of 16 years are strictly prohibited from entry.

Operational timings of the **HEALTH CLUB** facilities at the **RESERVE STAND**, consisting of the **GYMNASIUM**, **STEAM** and **SAUNA** is as follows:-

**GYMNASIUM**is open all days from 7.00 am to 9.00 pm (under the guidance of a Trainer from 4:00 pm to 8:30 pm except on Monday).

**STEAM** / **SAUNA**: Ladies 11:00 am to 4:30 pm and Gents: 5:00 pm to 8:30 pm

Members may contact the Club Department for enrolment.

Associate Members are issued Metal Badges for self, spouse and a lady guest and one 'Car Park Sticker'. Guests (up to four) may be signed in by the Member on payment of guest entry charges, which is presently Rs.100/- plus taxes as applicable per head. A member signing in a guest has to mandatorily be present till such time the guest is availing of the facilities in the Club.

Associate Members are requested to restrict themselves signing in a guest for a maximum of four times a month.

Entry to the Club would be subject to display of 'Associate Membership Badge' issued for the year on payment of an "Annual Subscription" and "clearance of all dues" for the previous year. No "Club Bills" for facilities availed by the member shall be kept outstanding more than thirty days from the date ofbilling.

Dress code notified by the Stewards, RCTC must be followed as advised from time to time. However, for non- racing hours Shirt / Collared T-Shirt and covered shoes (no sport shoes) would be mandatory for entry into the Reserve Stand.

Associate Members using club facilities may sign for food, liquor and other facilities as per charges applicable and advertised from time to time. Bill for the same will be generated and sent on a monthly basis.

Badges and Passes for Associate Members and their guests shall be issued as per the Stewards orders applicable from time to time for specific events as advertised.

The Stewards may prohibit the furnishing of supplies to any Associate Member whose name is posted or continues in debt to the Club for a month after demand.

Associate Members must pay for all articles of Club property lost, broken or damaged by themselves or their guests. The amount to be charged shall be fixed by the Stewards at their sole discretion.

Animals shall not be brought into the Reserve Stand.

Associate Members shall be responsible for their guests' observance of the Rules of the Club.

Dinner / Lunch/ Special event charges shall be advertised by order of the Stewards, RCTC from time to time.

Elegant attire is a tradition in RCTC. Ladies and Gentlemen who continue to honour this tradition are always appreciated.

Suggestions and complaints shall be made to Club 'Secretary' in writing.

Associate Members will be debited a minimum quarterly billing, which is presently **Rs.4000/-(Rupees Four Thousand only)** plus taxes as applicable.

Associate Members' shall have equal rights as RCTC 'Club Members' **except** voting rights and rights to attend 'General Meetings' of RCTC. Further a Associate Member cannot be elected as Stewards of the Club and also cannot be a part of any committee formed by the Stewards.

An Associate Member can second a proposal for Associate Membership after being a member for three years.

The Stewards of the club may from time to time make minor changes to the terms of Associate Membership.
