CALCUTTA RACES

MONSOON MEETING, FIFTH DAY, WEDNESDAY, 21st SEPTEMBER, 2022

No False Rails

1st RACE (19) THE STATE TREASURE HANDICAP – For Horses Rated 1-26 (About) 1400 Metres (2.30/2.31) : 6 runners

TOO MUCH POLITICS (Vinay Jaiswal) which was extremely difficult to load, jumped out awkwardly from the gates. In view of its behaviour Tr. Vikash Jaiswal was advised to give his charge adequate gate practice before accepting with it again.

SONG OF THE SOUTH (App Rupal Singh) was slow to begin.

2nd RACE (20) THE REPLICATE HANDICAP – For Horses Rated 41-66, Rated 21-46 eligible (About) 1400 Metres (3.00/3.01) : 6 runners

SILVERITA (Hindu Singh) was difficult to load. In view of its behaviour Tr. Bharath Singh was advised to give his charge adequate gate practice before accepting with it again.

SHIVALIC GOLD (App P Tejeshwar) was fractious in its stall.

GHOST (App L Alex Rozario, drawn 1) and BAHULEYAN (Suraj Narredu) made contact with each other soon after the start.

Jockey Suraj Narredu, the rider of BAHULEYAN, reported that his mount jumped awkwardly from the gates.

The Veterinary Officer reported that :-

- a) BAHULEYAN returned bleeding from its nostrils. Tr. B Mahesh was informed not to accept with his charge until certified fit by the Veterinary Officer.
- b) SILVERITA returned with cut injury on right stifle.

3rd RACE (21) THE SKYEXCH.COM MILE CUP – For Horses Rated 21-46, Rated 1-26 eligible (About) 1600 Metres (3.30/3.32) : 7 runners

NAZAAKAT (App P Tejeshwar) was very difficult to load. In view of its behaviour Tr. Ms. Arti Doctor was advised not to accept with her charge until shown to the satisfaction of the Starter in a barrier trial during the hours of morning track work.

CREATION OF GOD (T S Jodha) was fractious in its stall.

Jockey Nikhil Naidu, the rider of MORESCO, was reprimanded for allowing his mount to drift out approaching the final bend inconveniencing CREATION OF GOD (T S Jodha).

4th RACE (22) THE SKYEXCH.COM CALCUTA FILLIES TRIAL STAKES – For Indian Fillies 3 years old only (About) 1400 Metres (4.00/4.06) : 6 runners

b f STORMWATCH, a declared starter in the above race, was examined by the Veterinary Officer on the morning of Wednesday, 21st September, 2022 and found to be lame on left hind. Under the circumstances the filly was permitted to be withdrawn on veterinary grounds. Tr. Vijay Singh was informed not to accept with his charge until certified fit by the Veterinary Officer.

BEAUTY BLAZE (Suraj Narredu) was difficult to load.

SONATA (Antony Raj S) was fractious to be stalled.

MALACHITE (C S Jodha) was slow to begin.

Jockey Suraj Narredu, the rider of BEAUTY BLAZE, was fined a sum of Rs. 3,000/- for excessive use of the whip (1st infringement).

Jockey A Imran Khan, the rider of QUEENSTOWN, was fined a sum of Rs. 3,000/- for excessive use of the whip (1st infringement).

5th RACE (23) THE BRUSH ASIDE HANDICAP – For Horses Rated 61-86, Rated 41-66 eligible (About) 1400 Metres (4.30/4.34) : 7 runners

Jockey Vinay Jaiswal, the rider of KIMAYA, was fined a sum of Rs. 2,500/- for arriving late in the parade ring.

KIMAYA (Vinay Jaiswal) was difficult to load.

The Veterinary Officer reported that KIMAYA returned lame on left fore. Tr. Vikash Jaiswal was informed not to accept with his charge until certified fit by the Veterinary Officer.

6th RACE (24) THE COURT MINSTREL HANDICAP – For Horses Rated 21-46, Rated 1-26 eligible (About) 1200 Metres (5.00/5.01) : 7 runners

POT OF GOLD (P S Chouhan) drifted out alarmingly passing the distance post in spite of the Jockey's best efforts. Tr. Patrick Quinn has been advised to take appropriate remedial measures.

MEMORABLE MEMORIES (Shezad Khan) was observed to drop back rapidly from about the 800 metres and finished the race detached from the field. Tr. Shafiq Khan was advised not to accept with his charge until it was capable of a better performance.

1. Urine samples. Urine samples from the following horses were taken for clinical analysis :-

POT OF GOLD	-	6 th Race.

2. Tr. Manvendra Singh was fined a sum of Rs. 5,000/- for not being present during the hours of morning track work despite several written/verbal reminders.
