

STIPENDIARY STEWARDS REPORT

CALCUTTA RACES

MONSOON MEETING, FOURTH DAY, WEDNESDAY, 26th AUGUST, 2026

False rails were in position from about 1100 metres to about 400 metres.

Penetrometer Reading 3.3 cms

1st RACE (21) THE BROWN WOLF HANDICAP – For Horses Rated 1-26 – To be ridden by Jockeys of Indian Nationality (About) 2000 Metres (2.00/2.00) – 5 runners

SIMRAN'S ATTITUDE was slow to begin.

FAR SUPERIOR dropped out of contention from about the 700 metres and HERMES dropped out of contention from about the 400 metres. Tr. Rutherford Alford was advised not to accept with his charges until they are capable of a better performance.

2nd RACE (22) THE SREEPRIYA PLATE – For Maiden Horses 3 years old only - Rated 21-46, Rated 1-26 eligible (About) 1200 Metres (2.30/2.30) : 5 runners

Jockey Yash Narredu (VALERIAN) reported that his mount was tending to hang out during the first furlong of the race and thereafter was hanging in during the final stages of the race. Tr. Ritesh EK was advised to take appropriate remedial measures.

TETSU drifted outwards when placed under pressure during the concluding stages of the race.

3rd RACE (23) THE THRIFTY ALLAN HANDICAP – For Horses Rated 21-46, Rated 1-26 eligible – To be ridden by Jockeys of Indian Nationality (About) 1600 Metres (3.00/3.00) : 7 runners

App Yash Saini (TYCOONIST) was fined Rs. 3,000/- for shifting course inwards passing the 200 metres forcing KEITARO (A Ashhad Asbar) to be switched outside. The App was further advised to report to the Jockey Coach Mr. Christopher Alford for appropriate guidance.

STAR POWER finished detached from the field. Tr. Deepesh Narredu was advised not to accept with his charge until capable of a better performance.

4th RACE (24) THE TRUE COLOURS HANDICAP – For Horses Rated 61-86, Rated 41-66 eligible (About) 1200 Metres (3.30/3.31) : 8 runners

At the request of Jockey P Trevor, MORANO was re-saddled at the start.

CASH N RUN ran detached from the field. Tr. Sabeel Shariff was advised not to accept with his charge until it was capable of a better performance.

5th RACE (25) THE CALCUTTA MONSOON SPRINT – For Horses 4 years old & over (About) 1200 Metres (4.00/4.01) : 6 runners

For failing to declare the weight in respect of his charge KING LOUIS, Tr. Neil Darashah was fined a sum of Rs. 1,000/-.

Jockey Vishal N Bunde (MERLET) was fined a sum of Rs. 3,000/- for excessive use of the whip (1st infringement).

6th RACE (26) THE GOLDLINER HANDICAP DIV I – For Horses Rated 41-66, Rated 21-46 eligible – To be ridden by Jockeys of Indian Nationality (About) 1200 Metres (4.30/4.30) : 10 runners

SEA EAGLE and DON'T STOP THE MUSIC were slow to begin.

Vet's report :

On the morning of Thursday, 27th August, 2026 HAVANA SKY was examined by the Veterinary Officer and found to be lame on right fore. Tr. Ajay Sharma was informed not to accept with his charge until certified fit by the Veterinary Officer.

7th RACE (27) THE GOLDLINER HANDICAP DIV II – For Horses Rated 41-66, Rated 21-46 eligible – To be ridden by Jockeys of Indian Nationality (About) 1200 Metres (5.00/5.04) : 9 runners

ROMAN SPIRIT planted, taking no practical part in the race. The Starting Stall Certificate has been revoked. Tr. B Rajender Reddy was advised not to accept with his charge until shown to the satisfaction of the Stipendiary Stewards in a mock race.

Tr. Vikash Jaiswal and Jockey Varun when questioned regarding the running and riding of FOUJITA, the Jockey stated that :-

- He was instructed to take a good jump, place his mount in 5th/6th position and to do his best thereafter.
- The filly jumped out awkwardly from the gates and thereafter he felt that she was not galloping smoothly but he continued to nigger her to improve position.
- He rode her out completely in the final straight.

Tr. Vikash Jaiswal corroborated the Jockey's statements and explanations.

The Stipendiary Stewards not being satisfied with the explanations tendered, decided to :-

- a) Suspend Jockey Varun from riding in races on 9th September and 16th September, 2026 and fine a sum of Rs. 50,000/- for the indifferent handling of his mount in the initial and middle stages of the race.
- b) Warn Tr. Vikash Jaiswal and advise him to ensure that his charges are run and ridden in such manner that leaves no room for query.

Jockey Varun was informed of his right to appeal.

1. **Change of rider** – As Jockey Nikhil Naidu was declared medically unfit to ride, the following substitution of Jockeys were permitted :-
